Reimbursement will decrease with increase in Medi-Cal patients. Systems face a risk of financial collapse under the current reimbursement model, if we don't</p>

Opportunities will exist to remodel our EMS systems such as modifying prioritized dispatch and patient care protocols. Other concerns involve the possibility of small rural hospitals closing and a shift to capitated payments for ambulance providers. Systems will need to predict the impacts and adjust accordingly to maintain system integrity.</p> <p>T. Lynch also provided an overview of Community Paramedicine (CP). OSHPD is expected to make a decision on CP on or about November 12th. There are a variety of issues with CP. Cost to provide services, 150 hours of training and there is no identified reimbursement model. Current reimbursement is based on patient transport to an acute care facility.
